

## **Getting approval for Continuing Education**

Fill out the [Continuing Education Approval form](#) and submit it along with supporting documents to Cathy Kirkpatrick at the Board office.

## **Annual Continuing Education (CE) Requirements**

Each renewal period, which is between July 1 and June 30 annually, a mandatory of 2 hours shall encompass state or federal controlled dangerous substance (CDS) laws, or review of the Oklahoma Veterinary Practice Act and applicable rules.

All continuing education that is Registry of Approved Continuing Education (RACE) approved by the [American Association of Veterinary State Boards](#) , will be acceptable.

There is no maximum for RACE approved online CE for DVMs and RVTs.

Registered Veterinary Technicians (RVT) - 10 hours
